## LIABILITY RELEASES – 2010

### **AMATEUR ATHLETIC WAIVER AND RELEASE OF LIABILITY**

In consideration of being allowed to participate in any way in the Ski Club of the Palm Beaches athletic/sports program, and related events and activities, the undersigned: (1) Agree that prior to participating, they each will inspect the facilities and equipment to be used, and if they believe anything to be unsafe, they will immediately advise their coach or supervisor and the event officials of such condition(s) and refuse to participate. (2) Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own action, inactions or negligence but the actions, inactions or negligence of others, the rules of play, or the condition of the premises or any equipment used. Further, there may be risks not known to us or not reasonably foreseeable at this time. (3) Assume all the forgoing risks and accept personal responsibility for the damages following such injury, permanent disability or death. (4) Release, waive discharge and covenant not to sue the Ski Club of the Palm Beaches, its affiliated clubs, their respective administrators, directors, agents, coaches, and other employees of the organization, and other volunteers of the organization, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and leasers of the premises used to conduct the event, all of which are hereinafter referred to as "releaser" from any and all liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releaser or otherwise. The skier acknowledges and accepts full and sole responsibility and liability for the operation of and any defects and other hazards in skier's own equipment.

### **PALM BEACH COUNTY PARKS & RECREATION OKEEHEELEE SKI COURSE ASSUMPTION OF RISK**

I certify that I am in good health and capable of participation in the activities of competition water skiing at Okeeheelee Park's ski course(s). I am aware that during competition and training, required during a tournament, that certain dangers may occur, including but not limited to the hazards and possible injuries associated with competition slalom skiing, trick skiing and ski jumping. In consideration of my participation in the competition water skiing practice event, I will and do hereby assume all the above mentioned risks, and will hold Palm Beach County Parks and Recreation Dept., Palm Beach County, its employees and agents harmless from any and all liability, actions, causes of actions, debts, claims, demands of every kind and nature whatsoever which may arise from or in connection with my participation in these activities.

I have read the above Palm Beach County Parks and Recreation Amateur Athletic Waiver and Liability Release and Okeeheelee Ski Course Assumption of Risk statements. I understand them and agree to all terms and conditions and affirm all promises, representations and warranties made by me as a condition and consideration for the privilege of participation in activities of The Ski Club of the Palm Beaches. I agree to be fully responsible for my conduct while participating in activities of The Ski Club of the Palm Beaches and/or for the conduct of the minor on whose behalf I sign.
